

The first Permanent Board of Directors was selected by NSNC Stakeholders at a public Town Hall that was held at 7:00 p.m. on Thursday, July 29, 2010 at the Northridge Middle School, 17960 Chase Street, Northridge, CA 91325.

The results are in! The Town Hall Election was held and 122 stakeholders voted for 24 candidates for 15 Board seats. More information to follow (including pictures) but I wanted to get the main information out to everyone – the candidates in **green and bold** were elected.

We received 24 candidate applications for 15 positions, so that is great! All forms were gathered by the Neutral Third Party (NTP) who will run the Town Hall [selection] Meeting.
