

Northridge South Neighborhood Council Minutes October 24, 2013

- 1) Call to Order & Pledge of Allegiance Chris Sales called the meeting to order at 7:03 pm. Christian Vaca led us in the flag salute.
- 2) Board of Directors Roll Call Dagmar Abarghoei, Andrea Alvarado, Judi Greenberg, Margaret Landers, Sal Pelaez, Chris Sales, Jan Scott, Christian Vaca, Virginia Watts, Diane Weston-Sulka. Absent Rob Baskerville, Donnal Poppe, Michael Savage, and Fred Youssif.
- 3) Approval of minutes from previous meeting Jan Scott made a motion to accept the minutes. 2nd by Sal Pelaez. Motion approved with 9 yes votes. One board member out of room.
- 4) Comments by public officials
 - a) CD12 Jessie Levine, field deputy for CD12 spoke about the 2014 Citrus Sunday event that will be held in May this year. She also told us that people are now allowed to farm on their parkways. Mitch Englander submitted a motion to Los Angels City Council to begin a study to field test officer worn cameras. The LAPD will be reporting back to the Pubic Safety Commission. The City Council restricted the use of bull hooks on elephants. The City Attorney is looking into prosecuting marijuana shops and taking a harder line against them.

- 5) Public comments Don Larson is working on contacting Trader Joe's about opening a store in our neighborhood where currently there is a 99 cent store. Don Larson said it will take about six months to get things moving. More will be known by the first of the year about the 99-cent store.

Chris Sales also spoke about the Children's Art Fair that was held at Callahan Charter School and he thanked Andrea Alvarado for all her hard work in organizing the fair, which included food trucks, activities for children and adults. A mural was painted on a wall at the school. Tom Bramsom resigned because of time

constraints he has currently and we will be replacing him next month. The Disaster Preparedness Fair went well. People received bags with emergency supplies.
