

## Northridge South Neighborhood Council Minutes November 21, 2013

- 1) Call to Order & Pledge of Allegiance Chris Sales called the meeting to order at 7:00 pm; Judi Greenberg led us in the Pledge of Allegiance.
- 2) Board of Directors Roll Call Present: Dagmar Abarghoei, Andrea Alvarado, Judi Greenberg, Margaret Landers, Sal Pelaez, Donnal Poppe, Chris Sales, Jan Scott, Christian Vaca, Virginia Watts, Diane Weston-Sulka, Fred Youssif. Absent: Rob Baskerville, Michael Savage We have a quorum of 12 board members.
- 3) Approval of minutes from previous meeting Donnal Poppe made a motion to approve the corrected minutes. Jan Scott 2<sup>nd</sup> the motion. Motion approved with 12 yes votes.
- 4) Comments by public officials
  - a) CD12 Jesse Levine gave us a budget summary from CD12. Chris Sales and Andrea Alvarado were awarded certificates from CD12 for the Art Fair that was held at Callahan Elementary School. Since we are approaching the 20<sup>th</sup> anniversary of the Northridge Earthquake we need to come up with plans for how to be safe if there is another quake. The cleaning of parkways and sidewalks now is the responsibility of the homeowners. The city is working on getting the checkcard going, and also working on broadband Internet throughout the city. The Mural ordinance will permit murals on single-family residences in CD's 1, 9, and 14. Sal Pelaez asked Jessie Levine about what progress is being made on the Vallarta market entrance. Jessie Levine will look into it. Chris Sales spoke to Jessie Levine about the difficulties we are having with the treasurer's documents and reporting. Sal Pelaez said he heard about a major development being planned in Porter Ranch. Jessie Levine will look into it. She said we were the only Northridge NC that participated in the YMCA Thanksgiving give away.

- c) Approval of Monthly Reconciliation Report Jan Scott made a motion to approve the October reconciliation report. 2<sup>nd</sup> by Diane Weston-Sulka. The motion

was approved with 12 yes votes. Jan Scott made a motion to approve the payments for the October/November website, the October storage unit, and the October Decision Publication article for October. 2<sup>nd</sup> by Donnal Poppe. Motion passed with 12 yes votes.

- e) Parthenia/Shoshone Elder Care Update The owner of the proposed site of the eldercare facility is in the process of suing the City of Los Angeles.

Motion passed with 12 yes votes. Motion passed with 12 yes votes.

He discussed the events that we participate in. Chris made a motion to approve the changes that were made and Sal Pelaez  $2^{nd}$  the motion. The motion passed 12 yes votes.
